TURNING POINT™ INSTITUTE

Established in 2001, TPI seeks to advance and develop psychotherapy studies, encompassing educational training, clinical practice, research, supervision, and to set benchmark of excellence commensurate with similar, internationally acclaimed, institutes of psychotherapy.



COURSE FOCUS AND APPROACH

The TPI Professional Diploma in Integrative Supervision is a post graduate training, designed primarily for qualified Counsellors and Psychotherapists who wish to become supervisors and enhance their professional skills and development. This course is accredited by IACP and meets their current criteria.

The course is an intensive 60 credit training, delivered part-time over 10 months. The training includes a blend of in-person and online delivery, totaling 120 hours (min) over the duration of the training.

This training uses an Integrative approach to Supervision and is based on a humanistic and psychodynamic framework. It draws upon key supervision modalities and contemporary theory and practice, including relational and creative aspects of supervision.

COURSE ATTENDANCE

Ten 2-day Friday & Saturday weekends: 10.00 a.m. to 5.00 p.m.
Participants must attend all modules.



SPECIFIC COURSE REQUIREMENTS

To be awarded the Diploma, participants, having successfully completed the course modules, will be expected to complete the following requirements:

- 25 sessions (minimum of 1 hour) of supervisory contact with supervisees outside the course (cannot include sessions with class peers)
- 6 hours (minimum) of supervision for the above. (Participants will be responsible for paying for their own supervision)
- Two written assignments
- Participants complete 30 hours supervision of supervision within the training
- A satisfactory supervisor's report (signed) from an external clinical supervisor



ASSESSMENT

Assessment is based on attendance, course work and clinical requirements, including written work and supervision skills development. There is no formal written examination. An external examiner is involved in the assessment. An appeals procedure is in place.

Module TP103: Procedural & Administrative Aspects of Supervision (10 credits)

Module TP105: Peer & Group Supervision; Supervision in an organizational Setting (10 credits)

Module TP106: Advanced Supervision (10 credits)

Module TP107: Practicum Assessment (5 credits)



LEARNING OUTCOMES

Upon completion of this Diploma programme and following a period of personal study, participants will develop the ability to:

- Engage in an effective supervisory relationship
- Establish clear contracting, maintain and conclude a professional supervisory relationship
- Understand and use different models of supervision in reflecting on their supervisory skills
- Apply reflexivity in supervision and utilize their internal supervisor
- Reflect on ethical decision-making in supervision
- Identify ruptures in the supervisory process and have the capacity to repair these effectively

- Once a place on the course has been offered and accepted a non-refundable deposit of €1,000 is required
